

Sir/ Madam,

I am directed to say that the Ministry of Education is implementing the Central Sector Scheme of Scholarship for College and University Students (CSSS). Under the Scheme 82000 fresh scholarships are awarded every year to the meritorious students having annual family income upto Rs. 8.00 lakhs. Every year applications under the Scheme are invited through National Scholarship Portal (NSP). For the current Academic Year 2021-22, Portal has been opened from 18th August, 2021 to 30th November, 2021, for inviting applications under CSSS scheme.

2. The Department has noticed that the CSSS renewal applications are lying pending at State Level and Institute Level for verification, thus resulting in delay in disbursal of scholarships to the renewal beneficiaries.

3. Therefore, the School Education Board is requested to verify the applications at the State Level on regular basis, and to issue directions to the respective institutes for verifying the application on priority basis. Further, the Board has to make continuous efforts toward getting maximum students enrolled under the scheme and assure that sufficient applications are received before the closure of the Portal so that maximum eligible underprivileged students can get the benefit under the Scheme.
